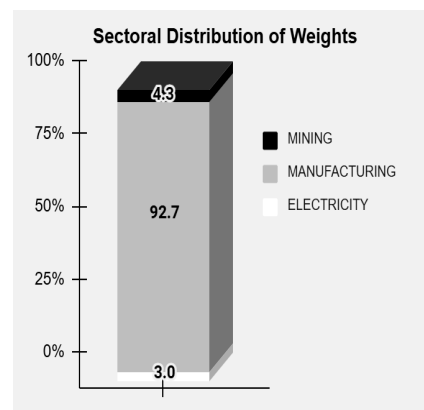

**INDEX OF INDUSTRIAL PRODUCTION (IIP)**  
 (BASE 2011-12 = 100)  
May 2025 – Final & June 2025 – Provisional

The Index of Industrial Production (IIP) serves as a short-term macro-economic indicator reflecting industrial growth and the status of production in the state.

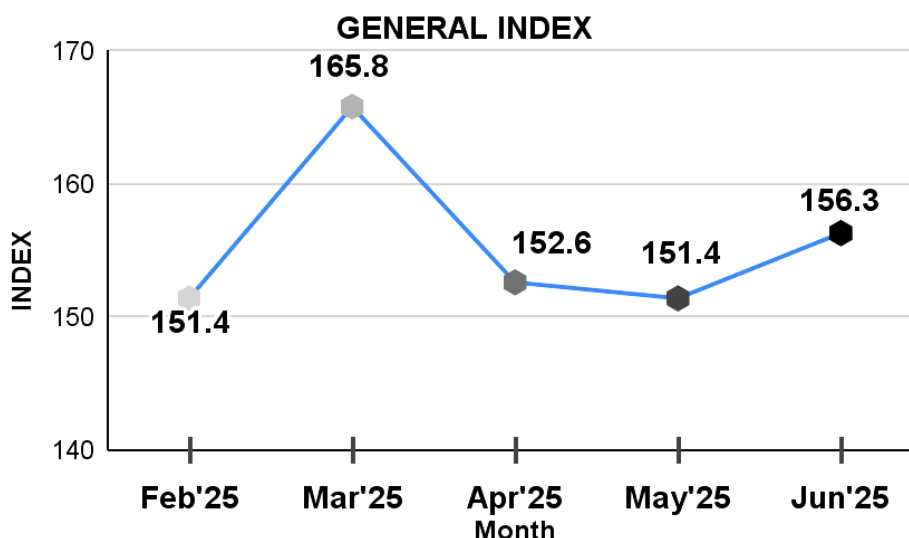
The IIP with base 2011-12 is compiled based on the data received under the mining, manufacturing, and electricity sectors. For “Mining sector,” data comprising 8 items are obtained from the Department of Geology and Mining, Tamil Nadu. Under “Manufacturing Sector” particulars are received on a voluntary basis, through monthly returns as prescribed to factories for 244 items. Indices based on production have been calculated at 2-digit and 3-digit NIC code-wise. For the “Electricity sector”, the electricity generation data is obtained from the Central Electricity Authority (CEA).

The weights for the Mining, Manufacturing and Electricity sectors are 43.82, 926.59, and 29.59 respectively, out of a total weight of 1000.



**GENERAL INDEX**

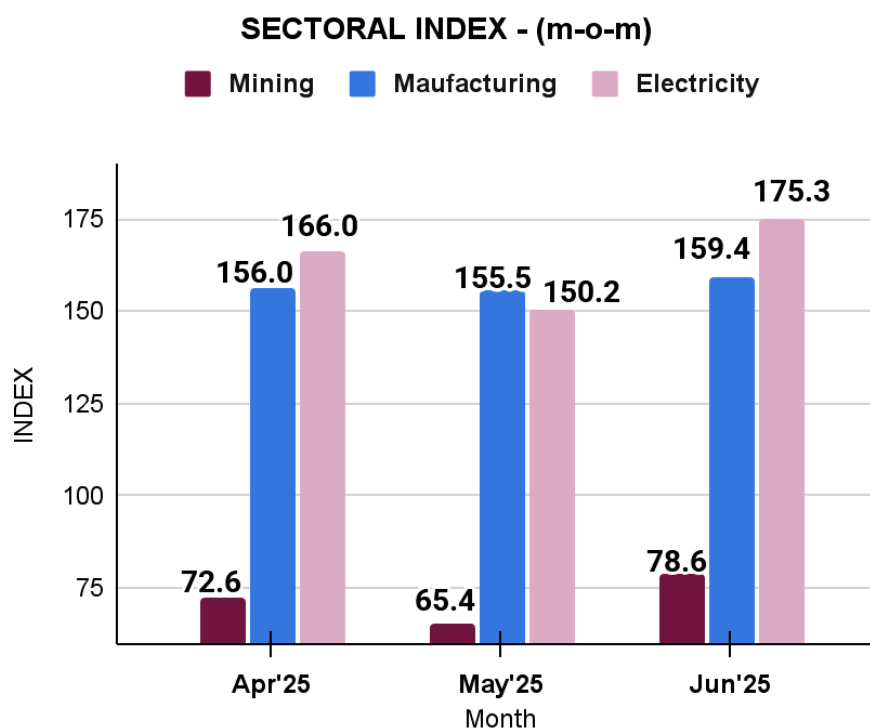
The General Index for May (F) 2025 and June (P) 2025 are 151.4 and 156.3 respectively, showing a positive variation of 3.2%. During the month of June 2025, the general index inclined as a result of an increase in all three sectors of mining, manufacturing and electricity by 20.2%, 2.5% and 16.7% respectively. The general index increased by 0.6% during the month of June 2025 over the previous year, June 2024. The average index (April'25 to June'25) had a rise of 0.7% when

compared with the corresponding period in the previous year. This significant increase was due to the increase in manufacturing by 2.0% (Statement 1).

### **Mining Sector**

The indices for the Mining Sector in May (F) 2025 and June (P) 2025 were 65.4 and 78.6 points, respectively, revealing a month-on-month increase of 20.2% (Statement 3).

The average index of 72.2 points (Apr.'25 to June.'25) decreased by 28.0 percent when compared with the average index of 100.3 points (Apr.'24 to June.'24) (Statement 1).

### **Manufacturing Sector**

The overall Manufacturing index for the month of June 2025 (159.4 points) had an increase of 2.5% over May 2025 (155.5 points) (Statement 3). The major reasons for the variations received from the factories imply "production increased based on orders/customisation and marketing plan/stock positioning" as well as "change of season." In general, the demand for the product claims to be the major proclivity of the indices.

The average index of 157.0 points (Apr.'25 to June.'25) registered an increase of 2.0% when compared with the corresponding period in the previous year (Apr.'24 to June.'24), which is 153.9 points (Statement 1).

At the NIC-2 digit level of the manufacturing sector, fourteen out of twenty-three industry groups had a positive variation in the average index (Apr.'25 to June.'25) when compared with the corresponding period in the previous year (Apr.'24 to June.'24) (Statement 2.2).

## **Electricity Sector**

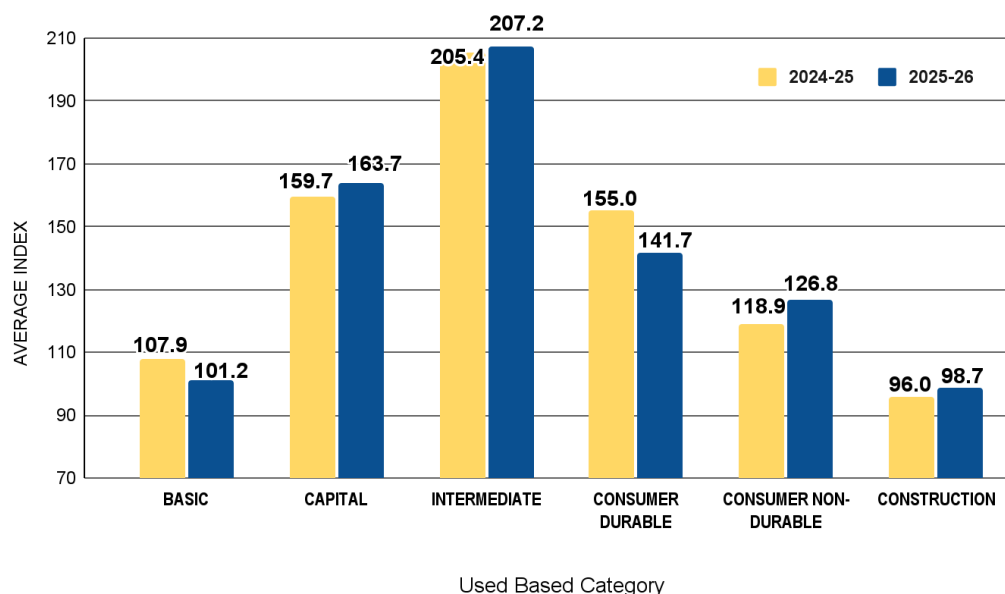
The Electricity sector stood at 175.3 points during June 2025, registering an increase of 16.7% from 150.2 points during May 2025 (Statement 3). The cumulative index for the period from April 2025 to June 2025 was 163.8 with a negative growth of 8.9 percent when compared with the corresponding period of the previous year (Statement 1).

## **USE-BASED INDEX**

The Use-Based Index (Tabulated in Statement 4) is the categorical index based on the products classified as per the industrial usage.

- ❖ The index for **Basic Goods** was 105.9 points in June 2025, showing an increase of 3.1% from 102.7 points in June 2024. The cumulative index for the period from April 2025 to June 2025 registered a fall of 6.2% compared to the same period in the previous year.
- ❖ For **Capital Goods**, the index was 165.6 points in June 2025, reflecting a decrease of 3.3% from 171.3 points in June 2024. The cumulative index for the period from April 2025 to June 2025 recorded a growth of 2.5%.
- ❖ The **Intermediate Goods** index was 213.6 points in June 2025, showing a decrease of 0.4% from 214.5 points in June 2024. The cumulative index for the period from April 2025 to June 2025 registered a positive growth of 0.9%.
- ❖ The index for **Consumer Durable Goods** was 140.0 points in June 2025, with a decrease of 3.7% from 145.4 points in June 2024. The cumulative variation for the period from April 2025 to June 2025 also showed a decrease of 8.6%.
- ❖ For **Consumer Non-Durable Goods**, the index was 126.9 points in June 2025, a rise of 10.5% from 114.8 points in June 2024 and the cumulative index for the period from April 2025 to June 2025 showed a rise of 6.7%.
- ❖ The **Construction Goods** index was 99.2 points in June 2025, with an increase of 3.2% from 96.1 points in June 2024. The cumulative growth for the period from April 2025 to June 2025 compared to the previous year is 2.8%.

In general, when comparing the Use-Based indices for the period from April 2025 to June 2025, all use-based indices showed positive growth except Basic Goods and Consumer Durable Goods when compared to the same period in the previous year.

## **CONCLUSION**

The Index of Industrial Production (IIP) for Tamil Nadu in June 2025 showed a positive overall trend, with the General Index rising by 3.2% compared to May 2025 and by 0.6% over June 2024. This growth was driven by the notable increases across the Mining (20.2%), Manufacturing (2.5%) and Electricity (16.7%) sectors. On a cumulative basis (April 2025 to June 2025), the General Index rose by 0.7% compared to the previous year, primarily supported by a 2.0% increase in the Manufacturing sector.

The use-based index reflects variations, with Basic goods (3.1%), Consumer Non-durable goods (10.5%) and Construction goods (3.2%) registering significant year-on-year growth in June 2025. However, Capital goods (-3.3%), Intermediate goods (-0.4%), and Consumer durable goods (-3.7%) experienced declines in the same period.

Despite some sector-specific contractions, the industrial economy displayed resilience and steady recovery, signaling a cautiously optimistic outlook for Tamil Nadu's industrial sector in the current financial year.
